
















SUSTAINABILITY

IS IN OUR DNA

Ever since it was founded in 1954, the company has been involved almost exclusively in recycling elastic raw materials, such as rubber, EVA and PU-foam. That has made **REGUPOL** one of the largest recyclers of such materials in the world. Recycling was the purpose of the company from the outset, even at a time when the term itself was largely unknown. That makes **REGUPOL** a pioneer in the circular economy.

Typically, **REGUPOL** products consist of between 75 -95 % of recycled materials. The same applies for the sports mats. **Regufoam**® is manufactured from genuine raw materials. For some products, additional features are available, such as surface coating, which are also made of primary raw materials.

REGUPOL has been certified with DIN EN 14001 continuously since 1997 and will maintain this certification in future.

All **REGUPOL** products and mats comply with the § 45 II No. 2 of the draft bill on circular econmy.

In 2016 we compiled a CO_2 balance for our production site with the help of the energy efficiency agency in NRW, in which we showed all our company's direct and indirect greenhouse gas emissions in CO_2 -equivalents. We save CO_2 emissions the equivalent to the emissions from more than 65,000 cars every year by manufacturing products from recycled materials rather than virgin materials.
